 - o Homelessness is up
 - o Sturbridge Bethlehem Church hosting Xmas function for migrants
 - o Continuing to grow networks, work on food distribution, and participate in webinars & trainings

- CMRPC Field Training Hub Mishel Caisapanta:
 - o Mishel provided a review of TRAIN MA, the new platform for MADPH training courses
 - o There will be MAPHIT Housing & Food refresher courses offered in January
- Discussion of tobacco enforcement contractor for Spencer & Wales
 - o Group discussed rates for contractor; services include initial outreach/education, annual inspection, youth sales, violation enforcement as needed
 - o Confirm credentialing, insurance/liability requirements
 - o Will look to Leominster & MHOA for service description/contract language
 - o Motion to expend CCPH funds on regional tobacco inspection & enforcement officer made by Jim, seconded by David. **Motion passes unanimously**.
