# \*\*Agenda Item: Approve Language of Floodplain Bylaw/MAPS/Definitions

Jason O. opened the public hearing at 6:02 PM.

As a participating National Flood Insurance Program community, updating the Flood Maps in the Quinebaug watershed is requirement of the town, in order to remain in the program. The planning board worked closely with two members of the MA Department of Conservation and Recreation to amend the Town of Wales Zoning Bylaws by deleting Section 3.0 Flood Plain District and replacing with a new section 3.0 Floodplain District. (see addendum) Nadia Madden from the MA-DCR was present virtually to offer support to the board by answering any questions from the board or community. The board agreed that an introduction section to the bylaw is not consistent with the format of our zoning bylaws. Doug Dickinson attended the meeting to get information on the updated language and mapping. Mr. Dickinson review the maps where his land is identified with Danelle L. Danelle L. was able to create an overlaying maps showing the differences in the previously approved mapping with the current changes becoming effective June 7, 2023. This is incredibly helpful for residents to get a clearer image of the minimal changes.
