

Meeting Minutes – April 1, 2022 ALL VIRTUAL MEETING

Rob H. opened the public meeting at 3:01 PM.

Old Business:

**Agenda Item: 30 Peck Rd. - Chapin Meadow Site- Norcross Wildlife Foundation-RDA

Rob H. reopened the public hearing at 3:02 PM. Dan Wilder explained the location of the site and the proposed work. Mr. Wilder explained that this particular area where the work is proposed has a very unique ecosystem, where they would like to promote further growth, but invasive species are present. Norcross has contracted out with an ecological services company out of Cambridge, MA to manage the invasive species. The work proposed includes physical removal of invasive species by cutting to knee length and then in the summer months they would be painting with herbicides via a handheld sprayer directed at the base of the plant. No soil disturbance is expected on the site other than walking around the site for application. Hugh B. wanted to know if any spraying would take place within 100 ft. of the brook. Mr. Wilder explained that the goal is to stay as far away from the brook as possible, spraying would occur by hand within inches of the base of the plant, performed early in the morning to reduce chances of wind drifts due to high wind. If it is too windy then application will not take place that day. Garlon herbicide will be used and is designed for application in a wetland environment. Mr. Wilder anticipated after treatment this year and reassessing next year that additional application will be needed. If that happens the commission will be notified. Mr. Wilder and Norcross want the native vegetation to thrive and invasive species to struggle. Putting effective management in place will promote the growth of the unique species.

Other Business:

Stafford-Holland Rd. – BSC Group

The commission previously approved and conditioned utility pole work on 12/20/21 where a pole was to be located on the North West Bank. The commission observed a pole on the North East Bank in Stevens Brook. This is a violation of the conditions issued by the commission because it altered a resource area. The commission will be reaching out informally to the point of contact (Carolyn Gross) from the BSC Group informing them of the violation, requesting that the pole be moved 25 ft. from the bank and that they restore and stabilize the area. The clerk had recently reached out to Ms. Gross and it was conveyed to the commission that they planed on conducting a site visit to investigate this, the commission would like to be present for the site visit.
