## \*\*Agenda item: <u>40 Sizer Dr./Sunpin Energy Services</u>

## Hugh B. opens the public hearing for 40 Sizer Dr./Sunpin Energy Services.

Joseph Orzel from Lucas Environmental, LLC, reads through and summarizes the comments made by Lucas Environmental, LLC, regarding the review of the Notice of Intent documents as well as the site visit to review the delineated wetland boundaries for the property located at 40 Sizer Dr.

Matthew Leidner from Civil Design Group, LLC reviews and summarizes the comments made from the engineering standpoint. Mr. Leidner would like to have an open line of communication between himself, and the applicants engineer. The commission feels that this is necessary to move the process along, with the condition that all conversations include the commission, and the commission receives an overview of these conversations that do not take place via email, so the public can stay informed.

The commission then asks Mr. Orzel and Mr. Leidner to expand on some of their comments within the NOI review letter. Some of the concerns that commission had were regarding acidic storm water runoff, validating the intermittent status of the stream, obtaining new FEMA maps, concerns of tree topping and hyper growth, cold water fishery and the stability and design of the box culvert.

Stephen Herzog states that revisions were submitted on the 24<sup>th</sup> of September, with the understanding that the commission along with Lucas Environmental did not have the appropriate time to review those comments. Mr. Herzog is willing to discuss questions and concerns that the commission and Lucas Environmental may have, in hopes to have a final submission to be voted on by the commission's next meeting.

Hugh B. continues the public hearing for 40 Sizer Dr./Sunpin Energy Services to the next month's meeting on October 21, 2021 at 6PM. If revisions are not submitted two weeks prior, the commission will hold a special meeting separate from regular monthly meeting.
