<u>Discuss and vote to adopt the recommendations of the Insurance Advisory Committee (IAC) pursuant to</u> their actions of April 28, 2020 & **Old Business** FY 2021 Budget

The Insurance Advisory Committee has had a few meetings since the committee was formulated and the IAC recommended level funding of Chapter 32 B Line but was unable to make suggestions that would balance the budget. Therefore, the school budget will need to be reduced. Initially the Wales Elementary School presented a budget of a 10% increase, but the budget landed on a 7% increase. Once FY 2021 Budget is balanced the Wales Elementary School will still see about a 4% increase from last years budget.

The recommendation of the IAC was to adopt "plan change option 1" which would generate some plan alterations.

Motion 043020-06 by Selectman Grasso to accept the recommendations of the IAC to adopt "plan change option 1" to the WES budget, Seconded by Selectman Valanzola

Selectman Valanzola recommends that a letter be sent to the Wales Elementary School with an updated budget that shows the adjustments of \$43,353.65 as a reduction to the WES budget and an increase to the Chapter 32 B Line item.

COVID-19 update/discussion/action plan
