CHAIRMAN'S ANNOUNCEMENT

"Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Wales Board of Selectmen is being conducted in-person and via remote participation. OPEN & PLEDGE OF ALLEGIANCE

The Chairman called the meeting to order at 6:00 p.m. leading the room in the Pledge of Allegiance.

NEW BUSINESS

Insurance Advisory Committee

The purpose of the joint meeting with the Insurance Advisory Committee is to review proposed changes to the town's health insurance plan design for FY2022.

Tara Fafard reviewed the Benchmark 4 plan design as it compared to the current plan. The proposed plan reflects a 5.31% overall increase, but by moving to Benchmark 4, the town saves 7.41% (town and subscribers) over the current plan.

Ms. Fafard also reviewed the Town of Wales Select Network Plan for an alternative plan comparison. This Select plan has a smaller list of approved health providers, but provides a 23.5% decrease over the current plan.

Town Counsel reviewed next steps:

- Public notices to establish the Public Employee Committee (PEC) to include a member from each bargaining unit and one retiree representative. Each will be asked to designate a representative.
- Each PEC member will receive notice of the proposed health insurance changes with comparison documents.
- PEC will have 30 days to review, negotiate the proposed changes and come to an agreement.

As referenced by Town Counsel, Ms. Leduc indicated she will send out notices to establish the PEC on Wednesday, February 24th via email correspondence, requesting receipt confirmation from each of the email recipients.
