** Agenda Item: Discuss Wireless Communication Correspondence w/Building Department

Sarah R. informs the board of the correspondence between SBA Communications and the Building Inspector. SBA Communications had reached out to the Town of Wales Building Inspector, submitting an application for the collocation of 3 antennas and the addition of a diesel-powered generator. Pursuant to Wales Zoning Bylaw Section 7.7.1.2 any proposed modification to an existing wireless communication facility must be done through the Special Permit process through the Town of Wales Planning Board. SBA Communications believed that they may be exempt from this process per FCC guidance. The Building Inspector may decide to follow up with town counsel if necessary.

**<u>Agenda Item:</u> Image Data Proposal – update from BOS Meeting

Sarah R. met with the Board of Selectman regarding the proposal for map digitization services. An explanation of the proposal along with next steps to take were discussed at the meeting. The Board of Selectman accepted the proposal, and the Executive Secretary submitted a petition to the Wales Finance Committee for a transfer of funds for no more than \$3,792.50. **Sarah R.** will be attending the Finance Committee meeting on January 27th, 2022, to answer any questions they may have.
