## Emergency Planning with Fire Chief, John Croke (JC) and Road Commissioner, Bruce Cadieux:

The last time we used a shelter was for the October 2011 storm at Norcross. We are at the drawing table at this point regarding setting up a shelter in Wales. We do not have a shelter in place, currently. We should use the Elementary School in a crisis. We do need a back-up generator. Do we want a stand-alone shelter or do we want a regional shelter? Typically the FD applies for a small grant every year for emergency management. We need new cots and some staffing. JV mentions that it would be prudent to sit down with Brimfield, first. Our discussion with Brimfield is our starting point. Our next step is to have a conversation with our neighbors to see if they are interested in regionalizing. MEMA's recommendation was to open up a regional tri-town shelter discussion.
